<b>FACTS</b>	<b>WHAT DOES TRAVIS CAPITAL PARTNERS DO WITH YOUR PERSONAL INFORMATION?</b>

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share relates to the contract that you signed with the retailer to purchase goods or services. This information can include: <ul style="list-style-type: none"> <li>• Social Security Number and Income</li> <li>• Account balances and transaction history</li> <li>• Credit history and payment history</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Travis Capital Partners LLC chooses to share; and whether you can limit this sharing.

<b>What we do</b>	
<b>How does Travis Capital Partners protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We authorize our employees to get your information only when the need it to do their work and we require companies that work for us to protect your information.
<b>How does Travis Capital Partners collect my personal information?</b>	We collect your personal information when you <ul style="list-style-type: none"> <li>• Apply for credit to purchase goods or services</li> <li>• Make payments on your contract or account</li> </ul> We also collect personal information from others, such as credit bureaus, affiliates, or other companies
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for Nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account

<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <b>Travis Capital Partners LLC has no affiliates at this time.</b>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <b>Nonaffiliates we share with are limited to the retailer from which we purchased your contract or account.</b>
<b>Joint Marketing</b>	A formal agreement between nonaffiliated companies that together market products or services to you. <b>Travis Capital Partners LLC has no joint marketing partners.</b>

<b>To limit our sharing</b>	Travis Capital Partners LLC does not share any of your personal information with any company that would permit you to limit the sharing.
