Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Travis Capital Partners LLC has no affiliates at this time.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Nonaffiliates we share with are limited to the retailer from which we purchased your contract or account.
Joint Marketing	A formal agreement between nonaffiliated companies that together market products or services to you. Travis Capital Partners LLC has no joint marketing partners.
